# GROWING COMPANIES SELECT RURAL ALABAMA FOR \$1.8 BILLION IN NEW INVESTMENT

A few years ago, we launched a new initiative to elevate our efforts to bring jobs and new investment to Alabama's rural communities through strategic economic development. I'm happy to report that since 2020, rural Alabama has been the destination for growth projects involving \$4 billion in investment and 5,500 anticipated jobs.

As outlined in our 2022 Rural Economic Development Impact Report, last year delivered robust results for Alabama's 40 "targeted" counties, which have fewer than 50,000 residents. Altogether, there were 43 growth projects in these counties, bringing almost \$1.8 billion in investment, along with 1,900 jobs.

Bottom line, the Report's results demonstrate that growing companies are increasingly considering rural Alabama for their plans because these areas offer plenty of advantages, including motivated workforces, training programs, a low-cost environment and much more.

The results also reflect the Alabama Department of Commerce's rock-solid commitment to sparking economic growth in the state's rural communities and creating meaningful opportunities for the hard-working citizens who live there. I want to thank Brenda Tuck, Commerce's Rural Development Manager, and her team for their unrelenting efforts to better position the state's rural areas for growth projects.

Working with our allies across the state, we made significant progress last year toward our goal of fully unlocking the growth potential of rural Alabama.

Consider some of the highlights:

- Arizona-based First Solar Inc., the largest U.S.-based manufacturer of solar panels, announced plans for a \$1.1 billion factory with 700 workers in Lawrence County, the largest project to land in a rural county in recent years.
- Georgia-based Advanced ACT announced plans for a remote air traffic control tower center in Selma that is poised to revolutionize air space management in the U.S. through its technology to serve multiple airports from one location.
- Pennsylvania-based Ecore International, which transforms reclaimed materials into high-performance flooring products, is investing \$25.5 million to open a state-of-the-art manufacturing and recycling facility in Ozark, where it will create 84 jobs.

We're confident that the momentum we've achieved will continue to reap benefits for Alabama's rural areas throughout 2023 and beyond. The state's rural communities are ripe for growth, and we will continue to work to ensure they are able to compete for — and win — high-impact growth projects that make a real difference.



# TOP 10 2022 ACCOMPLISHMENTS

**1** SIMULATED TRAINING AND READINESS

Rural Development's STAR Program continues to have a major impact, preparing counties to compete for new projects or project expansions within their counties. This 8-week program for each participant encompasses all aspects of an active RFI and emulates the actual site visit processes for an economic developer.

Within the first year of the program, we have completed training with 10 of the 36 rural developers, representing 12 of our rural counties. There are two currently in training that will have the opportunity to complete the program in 2023, with additional classes slated to begin in the both the Spring and Fall of 2023.

2 RURAL RESOURCE WEBINARS

Rural Development implemented 24 Resource Webinars in 2022 representing local, state and federal agencies, public and private resources, site development, community development and project funding resources, for a total of 65 featured resources over the past 24 months. These Resource Webinars are recorded and are available to the developers continually.

**3 RURAL WORKFORCE SUMMITS** 

In cooperation with Alabama's Regional Workforce Councils and Regional Planning Commissions, another Rural Workforce Summit was completed, with more being planned in various counties. These Summits bring at least 12 of the state's most valuable workforce resources into the rural counties to highlight the programs of On-the-Job Training, Work-Based Learning, Ready to Work, State Existing Industry Training Program, Federal Incumbent Worker Training Program, Alabama Technology Network, AIDT, Apprenticeship, and many others. Local and state subject matter experts are brought into the rural county to provide education on each program in

an atmosphere where local business and industry can forge the relationships needed for partnerships to utilize these programs on an ongoing basis.

COMMERCE LOCAL OFFICIAL TRAINING

Rural Development and Business Development teamed up to create and deliver a one-day local elected/appointed official economic development training to educate those who support rural development. This training explains the processes of economic development within Commerce and the roles of the local entities. Additionally, RurAL is supporting other elected official programs provided by partner agencies and organizations.

**5** ENTREPRENEURSHIP SUPPORT

In cooperation with the Alabama Association of RC&D Councils and the Commerce Office of Small Business, Rural Development is assisting rural counties in growing their own business and industry through support for entrepreneurship programs by identifying new programs and cultivating existing partnerships. RurAL acquired a \$25,000 grant from the Alabama Association of RC&D Councils to provide entrepreneurial workstations in 15 rural counties that had identified this as a resource lacking. Additionally, we are continuing to promote the many other agencies and organizations that support entrepreneurship for rural economic development.

6 RESOURCE SUPPORT & GRANTS

Rural Development has worked directly with funding partners to secure information and assistance for many of Alabama's rural counties to acquire grants at the appropriate times throughout the year that directly benefit their economic development efforts. In 2022, eight counties secured \$741,614 from USDA Rural Development after we featured this resource, its timelines and uses on a rural webinar. Rural Development is continually supporting our

other agencies and organizations that provide resources and assistance to further aid Alabama's rural counties.

INDIVIDUAL COUNTY SUPPORT

Rural Development consistently works on county county requests for assistance that includes, but is not limited to, project support, site development, building/educating the local economic development team, community development, and more.

SITE IMPROVEMENT & DEVELOPMENT

Rural Development constantly works to promote the development of additional sites throughout Alabama's rural counties through the identification of resources and property reviews, on an individual county basis. and collectively.

9 BUSINESS RETENTION & EXPANSION (BRE)

Rural Development is visiting local industries with rural developers and encouraging BRE programs to be included in every county to identify economic opportunities and provide resources specific to individual and collective existing industry needs.

10 COMMERCE RURAL SUMMIT

The 4th Annual Commerce RurAL Summit was held Oct. 25 and 26, expanded to include two days, and featured Speakers from across Commerce and agency resource partners. Secretary Canfield and Director Clem provided greetings and updates from Commerce Business Development. Governor Kay Ivey presented the STAR program partner agencies with plaques recognizing their valued participation; she also recognized the 15 counties that were creating new entrepreneurial programs from the RC&D grant. The 2023 Summit is expected to expand to three days and to be held at a larger venue.
